

**NYS WOODSMEN’S FIELD DAYS – CONTESTANT
RELEASE OF ALL CLAIMS AND WAIVER OF LIABILITY**

PLEASE READ CAREFULLY, THIS AGREEMENT IS LEGALLY BINDING. By signing below you give up your right to recover compensation through the courts or otherwise, for any damage to yourself, including death, or damage to personal equipment while attending the activity sponsored by the NYS Woodsmen’s Field Days, Inc. For the activities including but not limited to lumberjack and/or lumberjill sports; junior lumberjack and/or lumberjill sports, kayaking and/or canoeing; running and/ or walking; climbing a greased pole; tractor pulling; truck pulling; operating loaders or skidders; and any other events that you so chose to participate in at the annual NYS Woodsmen’s Field Days. This includes transportation to and from destinations within the event.

I, the undersigned, agree that these activities are inherently dangerous and may result in personal injury, death or damage to personal property.

I, the undersigned, hereby release, waive, discharge, and covenant not to sue the NYS Woodsmen’s Field Days, Inc. and any of the advisors, officers, servants, agents, sponsors, and employees of the above (herein after referred to as RELEASEES) for any liability, claim and/or cause of action arising out of or related to any loss, damage, or injury, including death, that occurs as a result of the undersigned’s participation in any or all events.

I agree to indemnify and hold harmless the RELEASEES whether injury is caused by my negligence, the negligence of the RELEASEES, or the negligence of a third party. I further agree that this RELEASE OF ALL CLAIMS AND WAIVER OF LIABILITY shall bind the members of my family and spouse, if I am alive, and heirs, assigns, and personal representatives if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above-named RELEASEES. I hereby further agree that this Release of all Claims and Waiver of Liability shall be constructed in accordance with the laws of New York State.

I also grant the RELEASEES the absolute permission to use, reproduce, or sell any pictures of me taken while participating in said activity. I hereby waive any right to inspect or approve these pictures, any caption, or text that may be used in connection with them, or to approve the use to which such material may be applied.
